

Issuance: Acceptable Matches on Names

When issuing a credential, it is important to carefully review the participant's name as it appears on the RAPIDGate Premier[™] credential versus the name as it appears on the participant's identification documents.



1. Review the two forms of identification provided by the participant.

- 2. If any parts of the two forms of identification are not sufficient matches, ask the participant to provide two forms of ID that do provide a sufficient match.
- **3.** If both forms of identification match, check the RAPIDGate Premier credential against the participant's identification.
